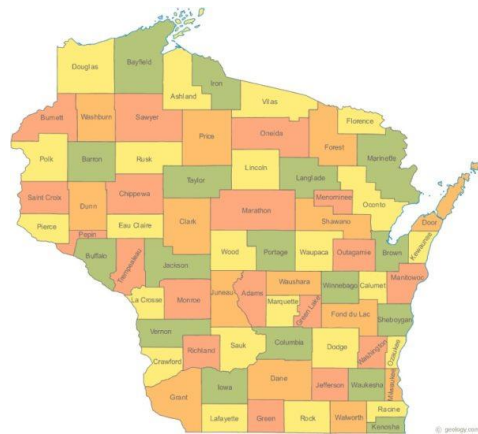




Out of State License: New Proposed Changes You Should Know About.
