



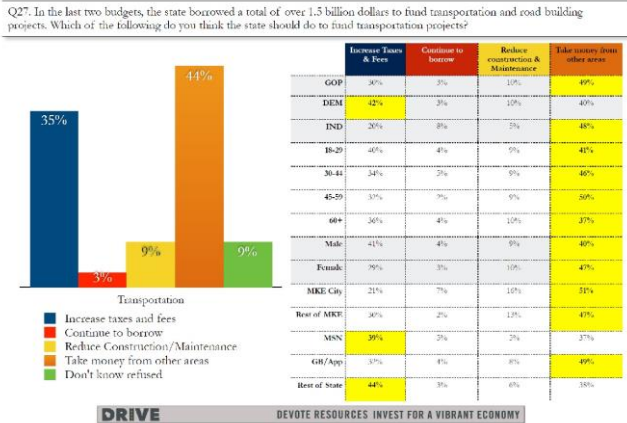
[State of Wisconsin Historic Tax Credit Update - Upcoming Research Release](#)

Since 1989, the State of Wisconsin has offered a 5% Historic Tax Credit (HTC) of the qualified rehabilitated expenditures on building projects and renovations across the state. On January 1, 2014, the Wisconsin
