Transportation funding is a top priority for CARW because of its impact on economic development. Earlier this month, the Wisconsin Department of Transportation (WisDOT) applied for the U.S. Department of Transportation 2017-18 Infrastructure For Rebuilding America (INFRA) grant. WisDOT is seeking a grant to support the construction of a vital portion of the I-94 North-South expansion project that encompasses Foxconn's manufacturing development and some of Wisconsin's other fast-growing employers. The INFRA grant will leverage over \$13 billion in private and public investment making Foxconn the largest single economic development project in the history of Wisconsin

and is the largest corporate attraction project in United States history as measured by jobs.
