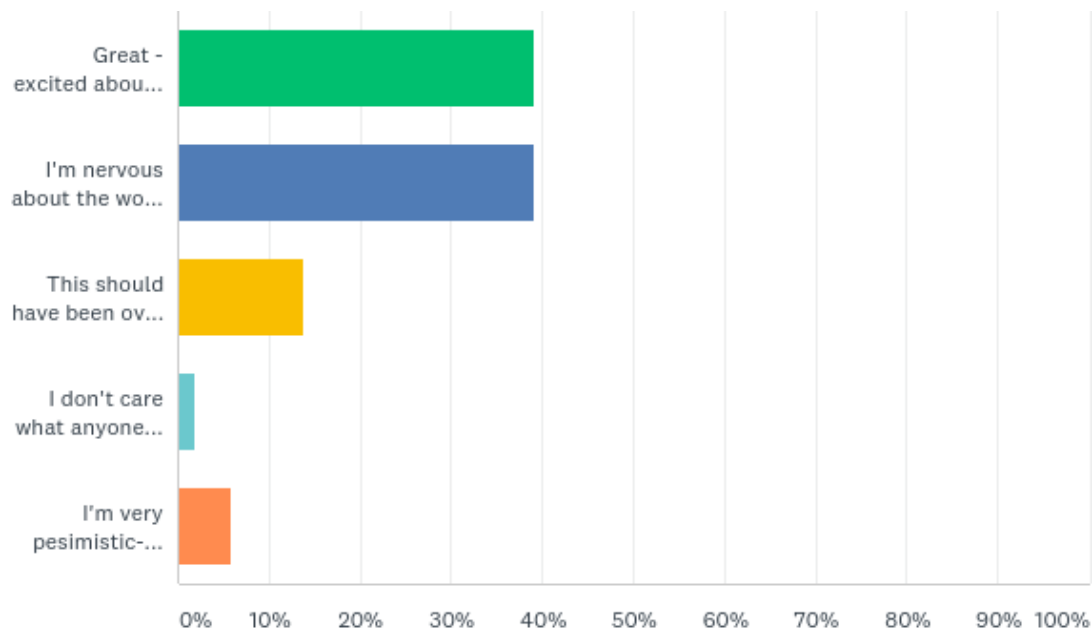

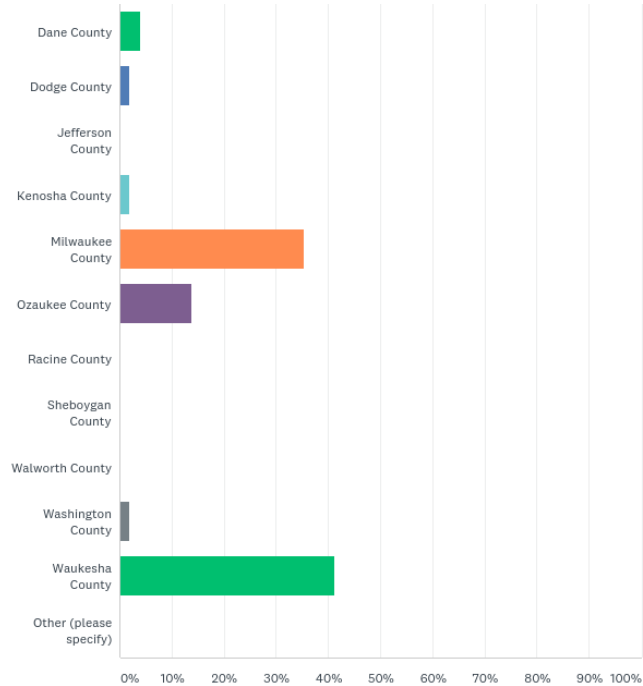

Q2: What County do you reside in?

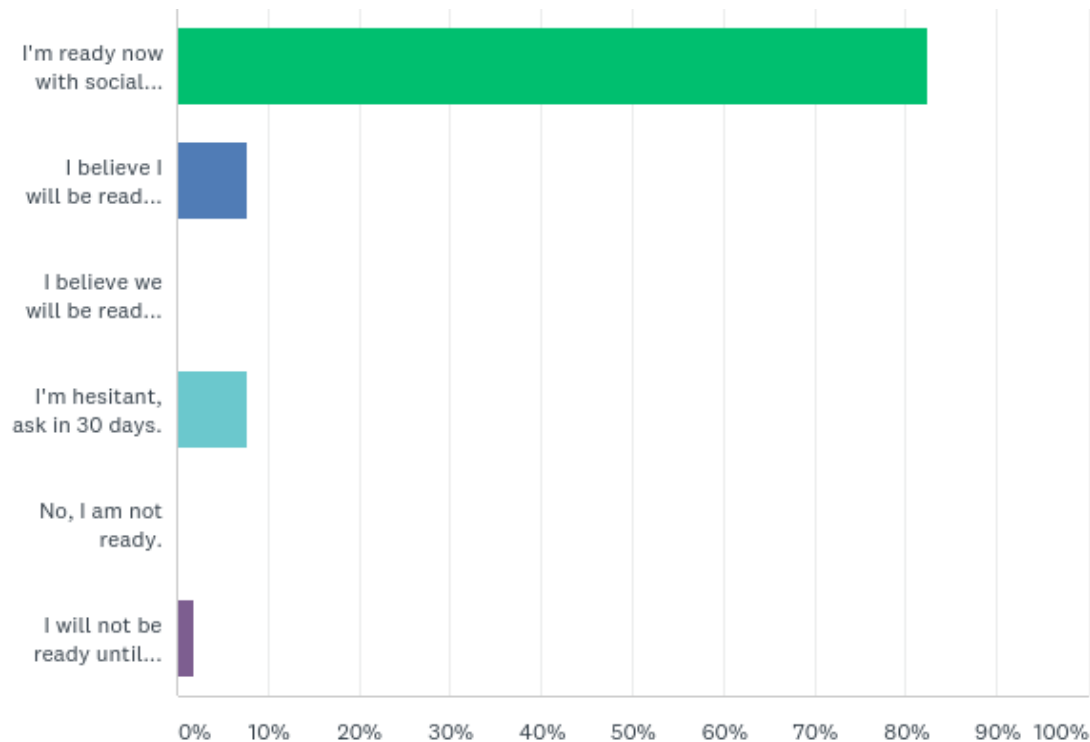

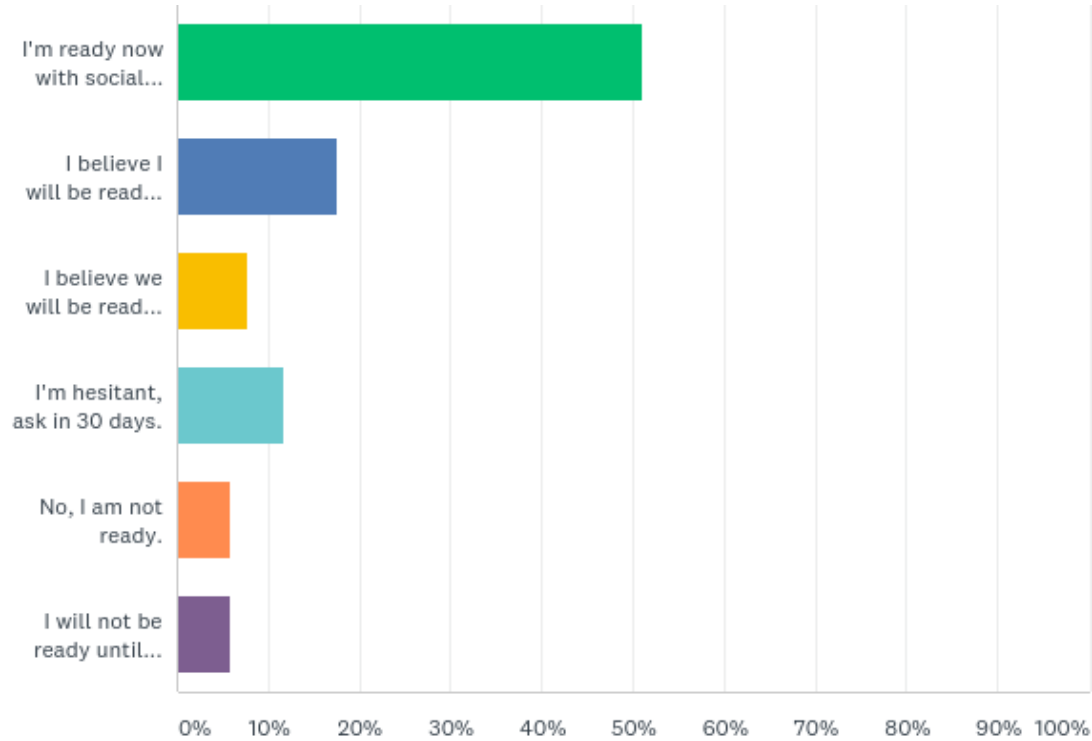

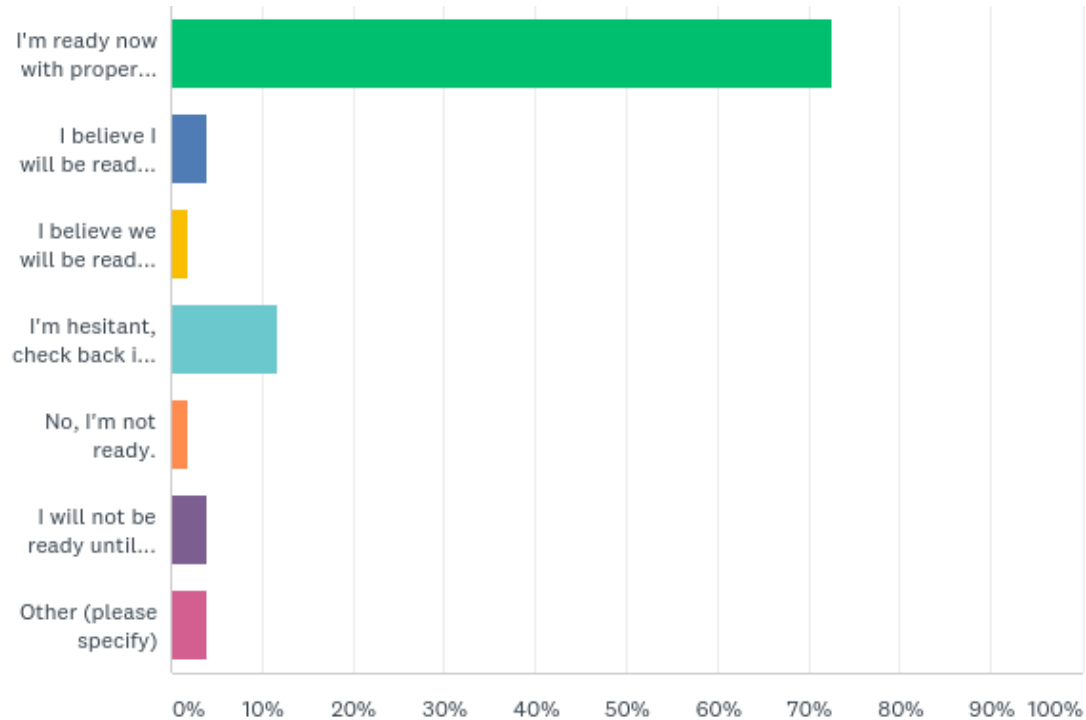

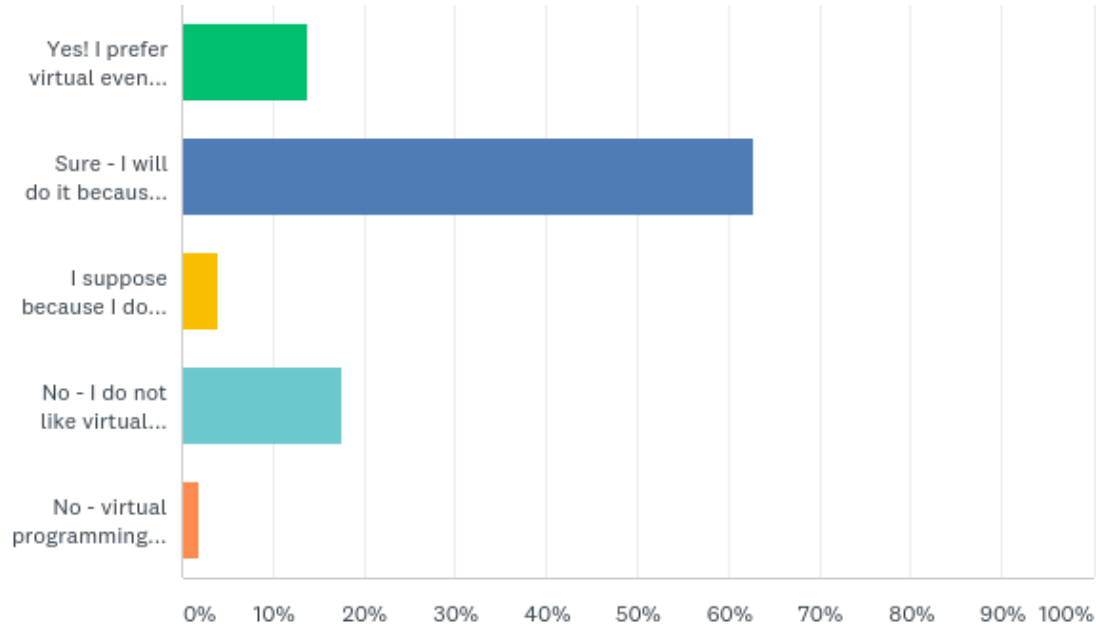

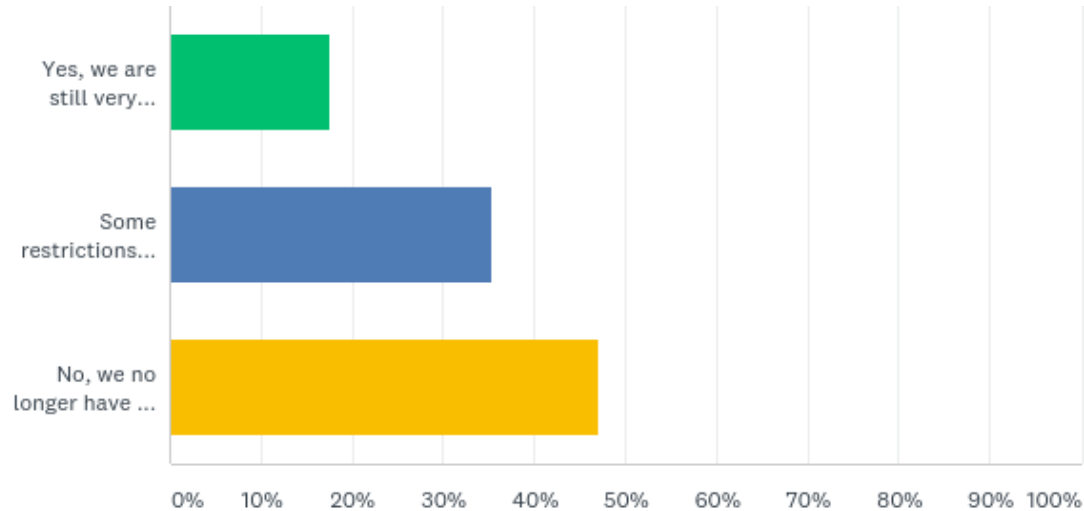

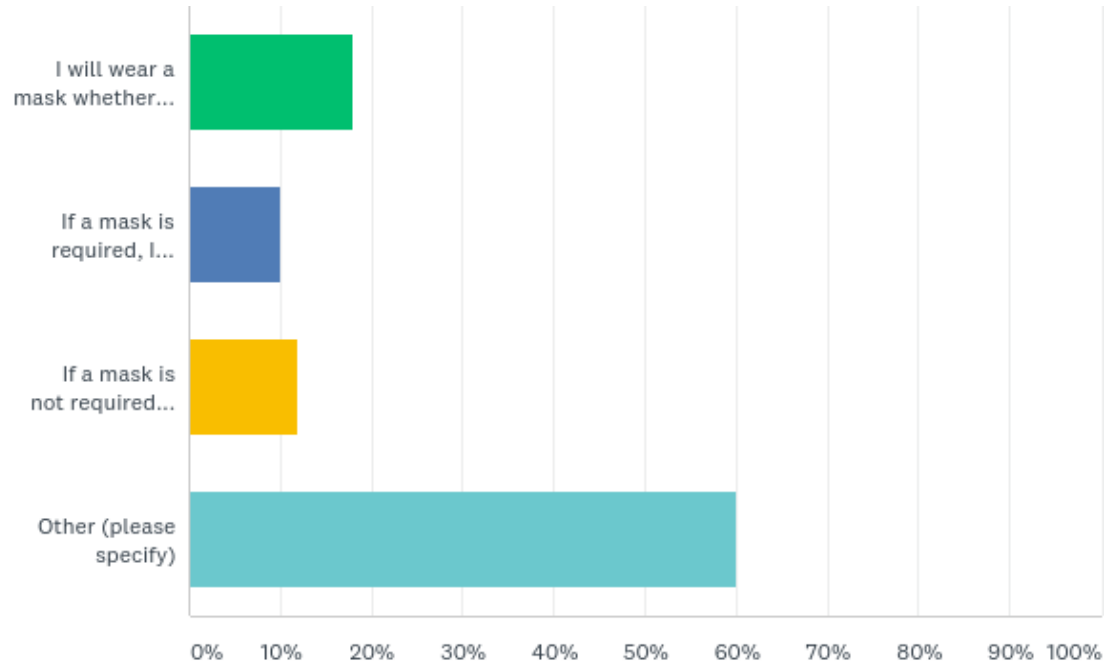

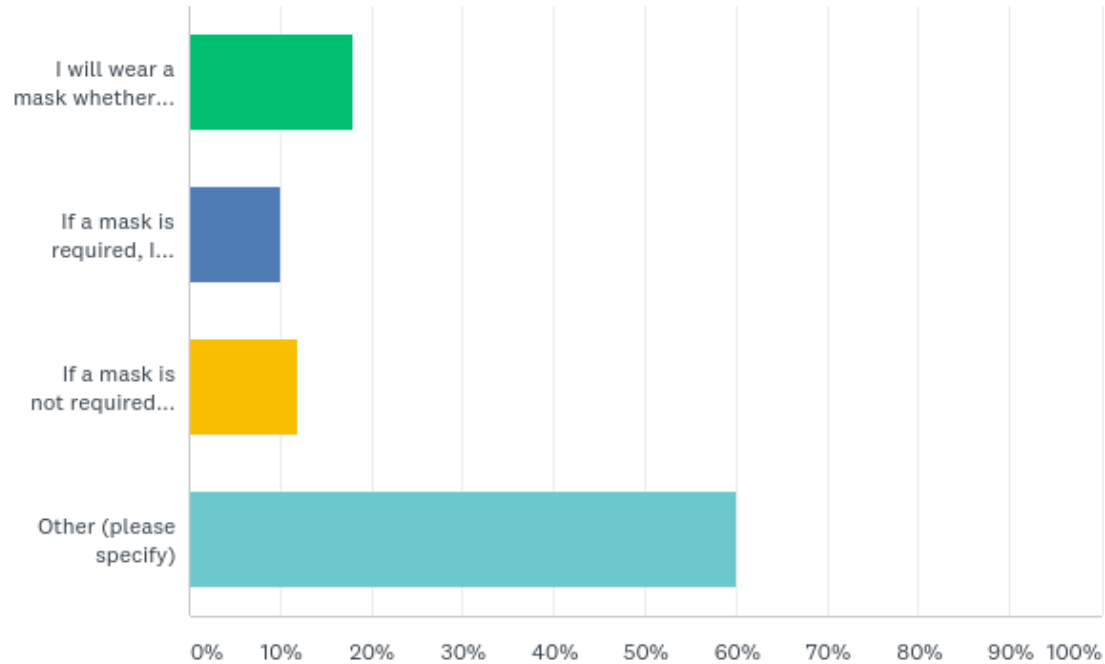

Q8: If we do in-person events, can you comment on your attitude towards masks?

- I will wear a mask if required, and participate. I am also comfortable without a mask.
- I will wear a mask if it masks others feel at ease.
- If a mask is required, the implicit message is that the venue is not considered safe. I will not attend a venue that is not considered safe - therefore, I will not attend a venue that requires mask wearing.
- I will wear a mask only if required
- Until a vaccine exists, I will wear a mask at an indoor event with larger groups of people.. The virus has not disappeared. Wearing a mask is simple and not a hardship for me, particularly when considering it can protect others.
- I think - especially leading up to the Nov election - masks will divide us. I have immunocompromised family members, but I feel that wearing a mask at a CARW event would negatively impact my career and opportunities.
