2022 Commercial Real Estate Hall of Fame Honoree J. Michael "Mike" Mooney



Mike Mooney is the co-founder, principal, and chairman of the board at MLG Capital, a real estate investment firm, headquartered in Brookfield, Wisconsin. As a veteran of the industry with over 55 years of experience in all aspects of real estate, Mike's vast knowledge can only be compared to his love of a forward-thinking company culture. Every day, he lives the core values of MLG: making a difference while making a living, and absolute integrity.

Mike's numerous board and leadership positions have included cofounder, Past-President, and longtime director of NAIOP-WI, Board Member of the Wisconsin Realtors Association, Director of the Wisconsin Economic Development Association, and a member of NAI Global's Worldwide Leadership Board, including two terms as Chairman.


