Scholarship Program Guidelines

The CCIM Wisconsin Scholarship was created to support qualified real estate professionals in their efforts to achieve the CCIM designation. Recipient should exemplify the high caliber of professionals that comprise the CCIM Institute.

Scholarship Selection Criteria

Each application is reviewed by the CCIM Chapter Board of Directors. A determination is made if it fits with the intent of the CCIM Wisconsin request. Individuals will be notified by email if awarded the scholarship and recognized in the June CCIM newsletter.

Application Requirements

- Individuals must contact CCIM Wisconsin to register for the course.
- Individuals must complete the application in its entirety to be considered and supply all information and forms as listed in the application.

- The completed application must be submitted to membership@carw.com for consideration by **Sunday, March 31st at 11:59 PM**. No late applications will be accepted.
- Recipients will be notified by **Friday, April 12th**.

Eligibility Requirements

- The scholarship is exclusively given to a professional with under 5 years of experience.
- Applicants must reside in Wisconsin.
- Must be a current REALTOR® member in good standing for at least 6 months.
- Recipient of this scholarship should have a need for financial assistance.
