LARGE DONOR COUNCIL

Large Donor Council members drive policy and decision making that impacts our commercial real estate industry. LDC members contribute a minimum of \$1,000 that is split in two parts: \$700 to the direct giver conduit which you have complete control of, and \$300 to RPAC which are dollars pooled with other RPAC supporters then directed by the RPAC governing board towards candidates from both parties who support CRE-friendly issues. You also receive policy-related communications, access to speakers and VIP opportunities and recognition.

- One Time Charge:** Please charge my credit card \$700 for the Direct Giver Conduit and \$300 for the REALTORS® Political Action Committee (or checks are enclosed).

CONDUIT

The Direct Giver Program serves as a personal donation “checking account” for individual members.

A conduit can be established with as little as \$250. The account is established and remains under your name. The REALTORS® Political Action Committee (RPAC) trustees and staff keep records and make recommendations for political contribution from your account, however, **you have the final decision** on any disbursements from your account. Contributions to federal, state and local candidates are distributed on a Direct Giver check. Each contributor is individually listed with an accompanying cover letter to the candidate’s campaign. A contribution check may be sent directly to a candidate for your convenience, or to you personally to deliver it to the candidate(s) you have chosen. The advantage is both you and CARW are recognized for your contribution. It’s like getting twice the bang for your buck!
